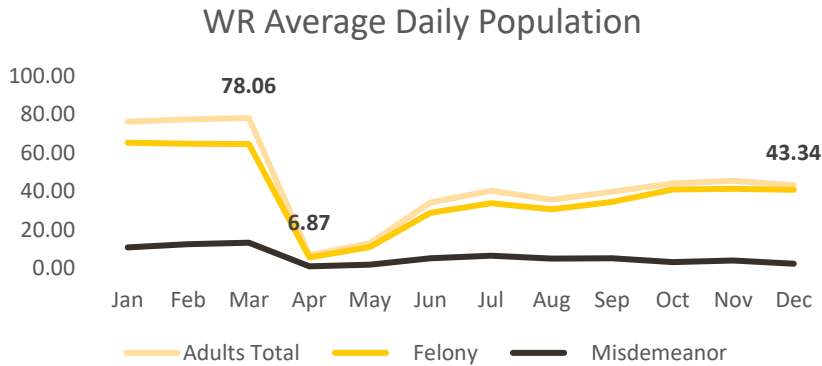


WCCC Annual Program Summary 2020

Residential Work Release



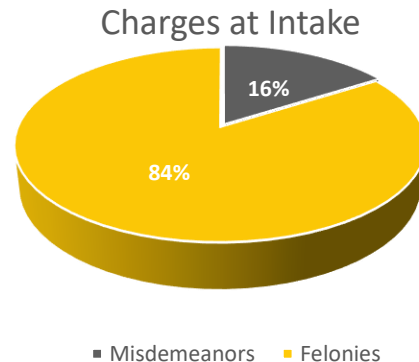
WCWR has had 157 individual intakes this year. There was a significant shift in population from WR to HD in April due to COVID-19. The annual high in March of 78.06 dropped to 6.87 in April, and gradually increased to 43.34 in December.

Of the 157 intakes, there were 6 CTP participants.

Offenses on intake include 25 misdemeanors with 24 being A Misdemeanor.

The 132 felony intakes break down as follows:

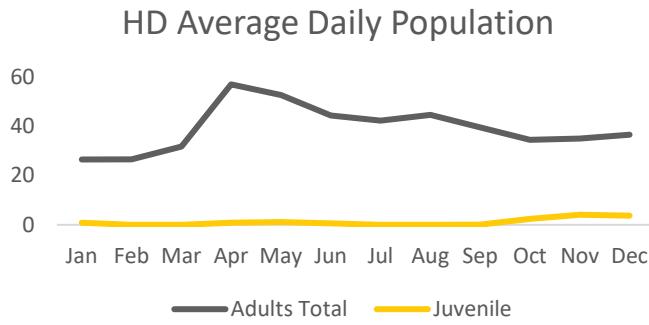
- 1 (1 %) A Felony
- 3 (2 %) B Felony
- 4 (3 %) C Felony
- 2 (2 %) Level 3
- 7 (5 %) Level 4
- 18 (14 %) Level 5
- 97 (73 %) Level 6



The goal of successful completion or modification of sentence is often met upon exit, however, terminations occur for various reasons. During 2020 there were 185 exits; during COVID-19 there were 22 furlough to accommodate participant safety.

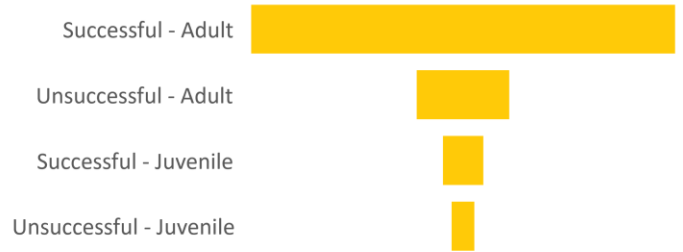
Home Detention



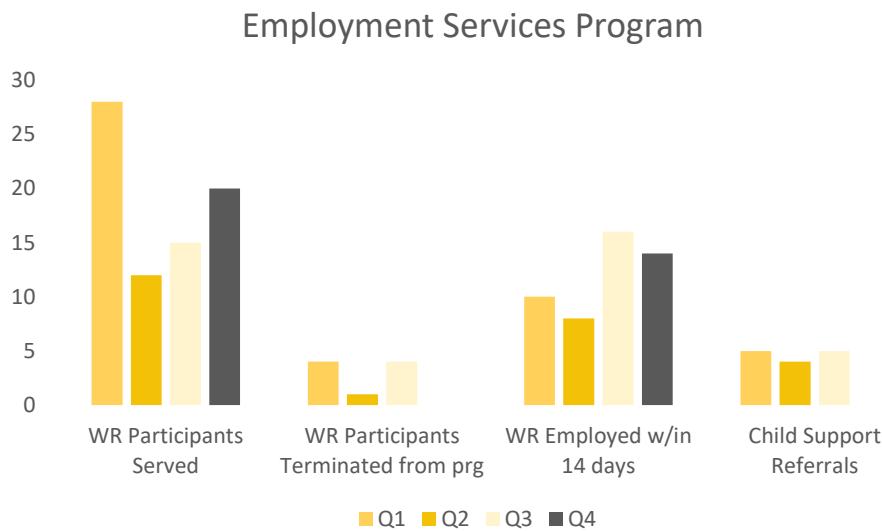
HD had 105 intakes this year with 78 (74%) being sentenced in Whitley County. 15 were courtesy supervision from other counties while 8 adult cases (down from 30 last year) were transferred out of county for HD supervision. Juvenile numbers have significantly increased in 2020 with a total of 12 juveniles being supervised. 19% of HD participants were convicted of misdemeanor charges and 79% were felony convictions, while 2% were status offenses.

82% of adult participants and 64% of juveniles successfully completed the home detention program.

Employment Services Program



The employment services program (ESP) worked with 75 participants in 2020. 71 (95%) of eligible participants were successfully employed within 30 days of completing the employment program. There were an additional 52 participants admitted to WR that had employment prior to intake.

Forensic Diversion

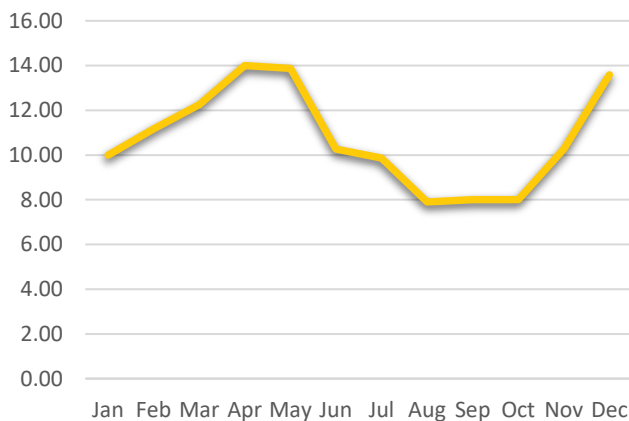
The FD program continues to provide direct service to residents of Whitley County and surrounding counties, as well as case management for those out of state as ordered. Program services were provided to **301** new clients this year. **222** individuals successfully completed the program.



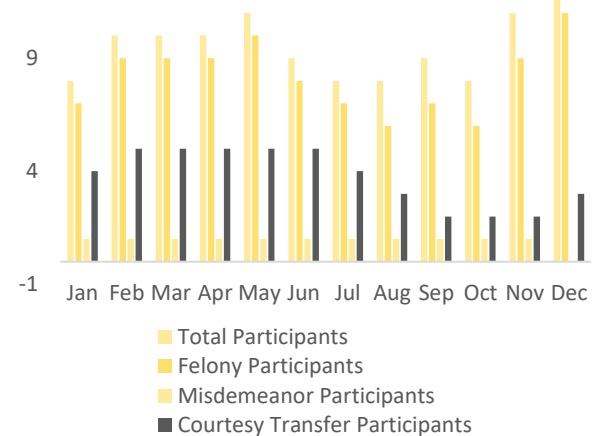
Veterans Treatment Court

The VTC team worked with 21 veterans in 2020. There was one termination from the program this year, however **7** veterans successfully **completed** the entire program.

VTC Average Daily Population

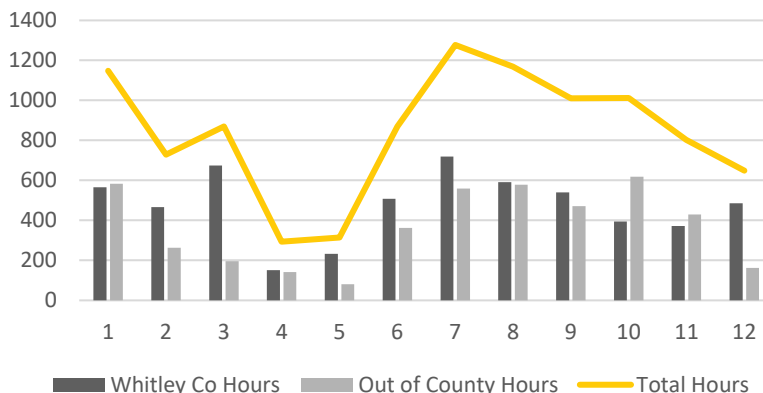


VTC Participant Count

Completed Community Service Hours

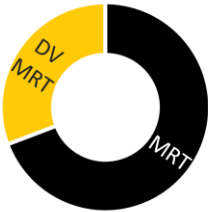


By scheduling specific days and times, and following protocols, individuals have been able to continue to give back to our communities in this time of COVID-19. Throughout this past year, community service hours have contributed \$78,005.58 in labor to our communities in northeast Indiana.

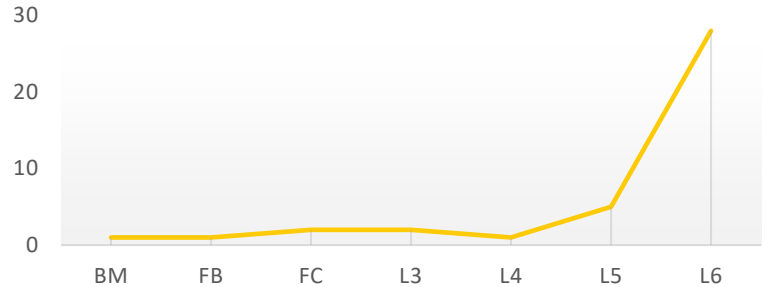
MRT

Due to restrictions related to COVID-19 all classes were suspended November 18, 2020 to ensure the safety of participants. The MRT classes served a total of 36 participants while the DV MRT class served a total of 9 participants; 26 individuals successfully completed classes.

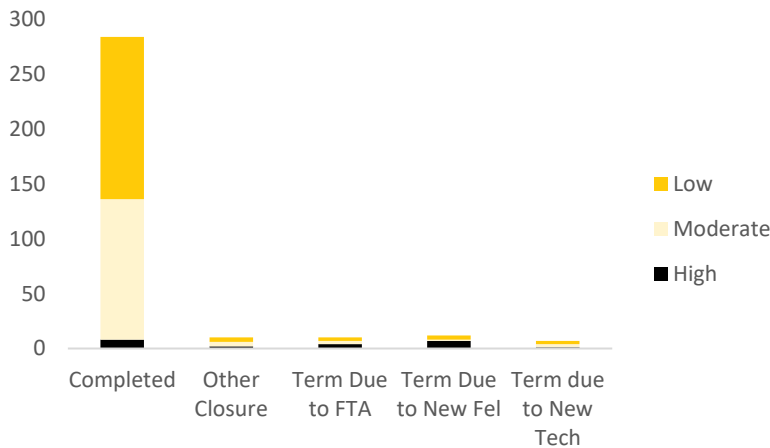
Successful Class Completions



MRT Referrals by Offense



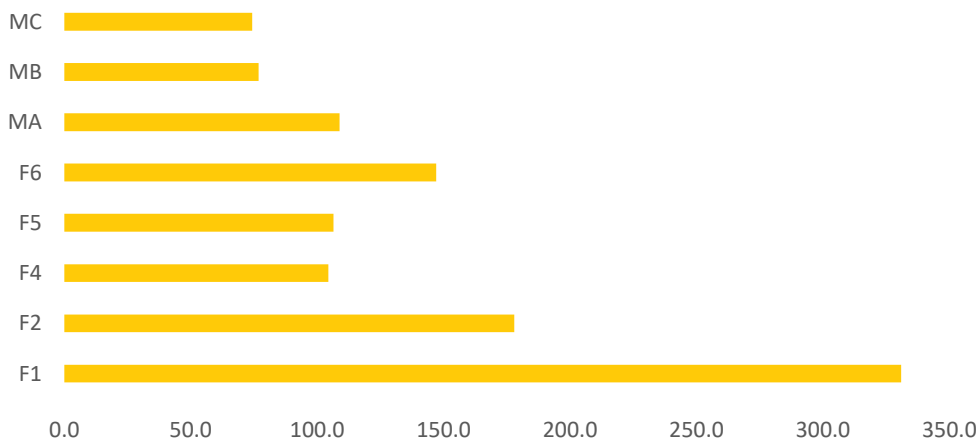
Pretrial Services



During 2020, PTS has grown to an average of over 340 clients on caseload. There were 328 defendants that completed the pretrial services program throughout the year.

Staff work diligently with the participants to maintain appointments and follow through with court orders to promote successful supervision. The current safety rate (percentage of defendants who complete supervision with no new offenses during 2020) is **99%**.

PTS has seen an overall increase in average days on supervision this year due to COVID-19 and a general delay in court hearings.
