**CFA-1 Candidate's Statement of Organization and Designation of Principal Committee**

Needs to be filed no later than noon ten (10) days after becoming a candidate, or noon seven (7) days after the final day and hour for filing, whichever occurs first. Candidates need to open a committee if the position that they seek receives over \$5,000 in compensation yearly.

You will need to file a CFA-4 Report of Receipts and Expenditures on the deadlines below if you are on the ballot (or would be, if unopposed) for the Primary & General elections and have opened a Campaign Finance Committee by filing the above CFA-1 form.

(Annual) For the reporting period October 12, 2024 through December 31, 2024.	December 31, 2024	<b>January 15, 2025 @ NOON</b>

\*\*\*Candidates are responsible for getting their own forms. You can refer to the Indiana Election Division Website [www.in.gov/sos/elections/2394.htm](http://www.in.gov/sos/elections/2394.htm), the county website [www.whitleygov.com](http://www.whitleygov.com) or you can request hard copies from the Whitley County Voter Registration Office.

\*\*\*Remember if you are not running under the same Candidate Committee name (CFA-1) in the future, or you did not win your election, you may want to **disband your committee** (see number 11 on the CFA-4 summary sheet). Otherwise, you are responsible for filing CFA-4 forms to maintain your committee yearly, regardless of whether you are currently a candidate on the ballot. If you fail to file, or are late filing the correct Campaign Finance forms, you shall be subject to a \$50.00 a day penalty by the County Election Board.
